Original nominees to pay \$2,500 to pass the entry box and \$2,500 additional to start. With \$500,000 Guaranteed. After payment of 1 percent to all starters finishing sixth through last, 60 percent of the remaining purse shall be paid to the winner, 20 percent to second, 11 percent to third, 6 percent to fourth and 3 percent to fifth. Weights: Colts and Geldings, 122 lbs.; Fillies, 117 lbs. NOTE: This Stake will be limited to fourteen starters. Preference will be given as follows: (1) To Graded or group winners in order (I,II,III). (2) Highest career (non-restricted) earnings. (3) Total career earnings. Two horses having common ownership cannot start to the exclusion of a single ownership interest. Failure to draw into race will cancel all fees.
